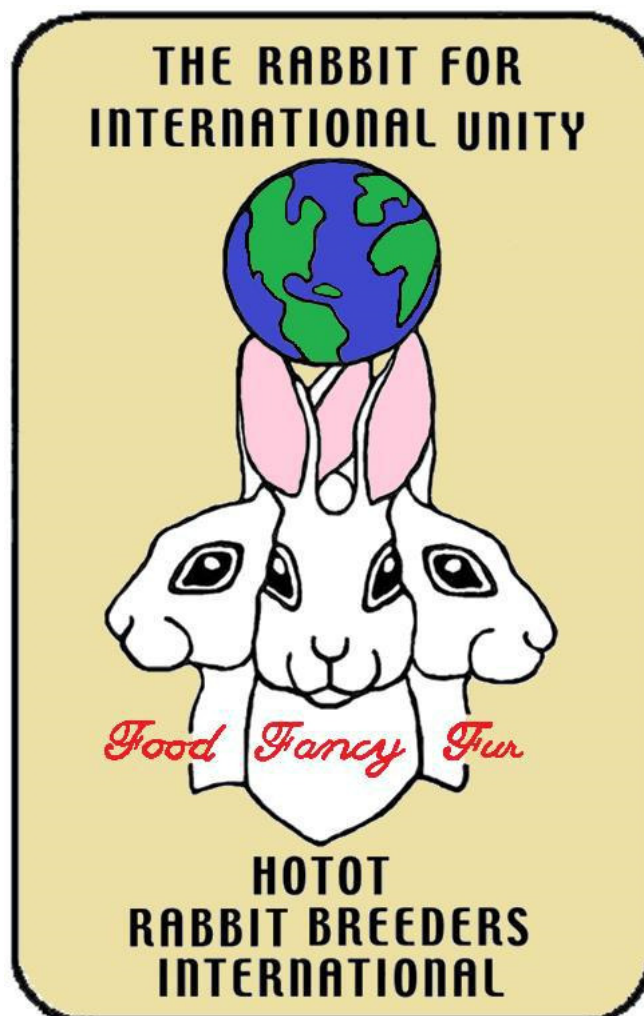

**Updates on HRBI Secretary-Treasurer situation:**

- 1) I received some checks from last Secretary-Treasurer Stacey Konency (thanks Stacey for your time and effort!). I cannot cash these checks since we don't have a club bank account yet. The club is awaiting to get the EIN which is required to open a club bank account. District Director 9 Brian Bell is actively working on the matter. We expect this to be done sometime in April. When we get it, we will also open a club PayPal account.
- 2) On 16 March 2018, I personally reimbursed JJ Story Veale for her claim for the expenses of \$171.27, dated from 16 May 2017, following the HRBI National, Specialty, and Rare breed Show held at the West Coast Classic in May 2017. The delay for her to be reimbursed for her expenses and efforts for the club was simply unacceptable.
- 3) The tentative balance is **\$2,281.78**, including checks that have not been cashed yet and excluding outstanding claims. When the EIN account is created and the situation is resolved, I will include a detailed account statement.

**Potential points to discuss at next HRBI meeting (date to be determined):**

- 1) HRBI Trophy and other awards: The Club Trophy has been shipped to last winner Samantha Sessamen. I know it has been discussed in the past when updating the C&BLs, but the club should establish clear directives on how to engrave the winner's name, ship the trophy and what is claimable to the club for reimbursement.
- 2) HRBI Logo: A new logo seems to have been created. It is pretty, however it should be voted by the club through a formal process.
- 3) From the last club minutes (January 2018): 'Secretary may pay normal operating expenses: shows, website, postage, etc. under \$250'. Since it is not in our By-Laws yet, I cannot action it.
- 4) Website: Who is responsible for the Website should be discussed. Having at least two people managing the club website and the HRBI Facebook page would be recommended to ensure redundancy.
- 5) CB&Ls: Maybe the matters discussed above reflect the fact that our C&BLs should be reviewed and potentially updated.

I would like to start off by introducing myself. My name is Aurora West. I was born and raised in Alberta, Canada about 2 hours west of Edmonton. I purchased my first "meat mutt" doe shortly after moving to my husband and I's small acreage in 2015. I started raising ducks the same year and discovered the Livestock Conservancy and quickly became passionate about raising rare breeds of small livestock. I began my search for Hotots shortly after but, upon learning that there were none in Canada and not knowing the importation procedures, I temporarily set that on the back burner. In 2017 I became aware that it was relatively simple to bring rabbits up from the US and began my search again! I am sure a few of you may recognize my name from messages you may have received during that time period. I want to thank each and every one of you for all the help and assistance you gave me! I purchased a buck in September and three does shortly afterwards which were flown up to me from Oregon. I now have 6 Hotots (2 of which should be kindling any day now) and I am planning a trip down to Washington in April to pick up a few more and hopefully attend the Eugene, OR show.

We do not have shows as numerous as you have down in the states, however its my goal to attend as many of the small local shows I can this year. I have already brought Hotots to two shows in 2018, one of which was my first show ever let alone with Hotots! There was significant interest shown and some disbelief as I was told numerous times that there have not been any Hotots in the province for 10 years! It was a great experience and I learned a lot, it was a double show and one of the judges was Autumn Dennistoun who gave me some tough but eye opening advice. There are two more local shows on the agenda before the end of summer and I will be working hard over the next while to promote the breed here. Please get in touch with me if you are willing to fly Hotots up to Canada for anyone who might be interested in starting with them.

We have one big local show coming up in Edmonton on July 27-29. It is being held in conjunction with K-Days. For those of you who are not familiar with what K-Days, it is a 10 day long "fair" of sorts but in very large proportions that has been held annually since 1879. There are amusement rides, live music, foods and displays from many different nationalities and much more! The rabbit community here is extremely excited for this as most if not all of our shows are Carrier Shows and this one will be a Coops show. I know it is a far trip for many but it would be great to see some other Hotots at the show! Free entry to K Days for exhibitors is one of the perks!

Other than my passion for the Hotot breed, I also raise ducks, sheep, and chickens. Presently I have American Blackbelly sheep, Saxony Ducks, Silver Grey Dorking and Rosecomb Rhode Island White chickens. This spring I will be adding Dutch Hookbill and

Aylesbury Ducks, Pilgrim and Pomeranian Geese, as well as a pair of Belgian Hares. Hoping to find a source for Holland White Turkeys as well but so far it has proven difficult. I also keep honeybees on a small scale at my acreage as well as my parents acreage. I am planning too start showing my poultry and I am also hoping to get involved with the local 4H group. It will be an extremely busy year and I look forward to every minute of it!

I am grateful to be in this Director position and will work hard to complete my duties to the best of my abilities. Thank you for your dedication to this breed, I only hope I can serve the breed and the club well going forward.

I am very excited having started as the new District 7 Director for HRBI in January. For those of you who don't know me, I started raising rabbits in 2002 with a blue Dutch named Lucky. I have raised a number of breeds since then and have recently acquired my Registrars License on Valentine's Day 2017! My current rabbitry allows me to have upwards of 50 rabbits, and I focus solely on quality over quantity in New Zealands and Blanc de Hotots. I got my start in Blanc de Hotots in 2016 thanks to some very helpful breeders across PA, IN, and WA in helping me obtain my foundation herd. I was fortunate to have my homebred doe, Sessamen's Boggart, win BOB at the ARBA Convention this past year in Indianapolis and was fortunate to present on this breed at the most recent PaSRBA Convention Judge's Conference.

D7 started off the year with a Blanc de Hotot sanction in Auburn, NY on January 6<sup>th</sup>. Unfortunately due to the crazy snow storm, I was unable to attend; however, congratulations are in order to Alexis Lichvarcik on winning BOB that day! Winter in the northeast leads to not many shows until around April, so I hope to see some more Blanc de Hotots on the tables as interest has been growing steadily in NY, CT, NH, and Canada. Mark your calendars for a Rare Breed Show in Auburn, NY on June 10, 2018 hosted by the Cayuga Lake R&CBA!

This fall I will be serving as your breed secretary at the 95<sup>th</sup> ARBA Convention in West Springfield, MA. I hope you all are breeding very soon to have nice sized 6/8's and juniors. We had a great turnout for last year's convention, so let's try to have even more representation for the #1 rare breed in 2018!

Now, I would like to take minute to talk about *animal husbandry*. The general definition of that term is "the science of breeding and caring for farm animals". Too often, I am approached by an individual who is wanting a rabbit to utilize in their own breeding herds and I often decline. I admit, years ago have sold rabbits quite often, but now maybe sell 5 per year, and that is due to the fact that I had animals end up in horrible situations that could've been prevented.

Rabbits require daily care and those wanting to positively promote this hobby should ensure that they are providing their animals with the utmost possible. i.e. You don't bring home your newborn child without setting up a proper and safe environment for them, and you don't leave them soiling in their diapers for days at a time. Why would you do the same for your animals? Take the time to feed, water, and clean daily! Personally, I check feed and water twice, distribute hay accordingly, wash water bottles,

spot clean trays, and sweep floors on a daily basis. Once a week I do a general health check of all animals, a deep scrubbing, sanitization and dusting of the entire rabbitry.

If someone were to drop by and inspect your barns this very minute, would you think they would find anything to cringe about?

## HOW DO YOU KNITT YOUR WORDS TOGETHER?

When is the last time you had a *really good conversation*?

If you're anything like me, you live for great conversations, the times when you feel like you really understand the person to whom you're talking, and you feel like the other person has truly heard you. There are very few things that can be as rewarding, invigorating, or thought provoking as truly excellent communication!

So then why does conversation come so hard?!

In my non-rabbit life, the one where I have a job and people see me on a daily basis not covered in fur, I am an educational administrator. We often talk about how to present messages so they can be heard, and how to create an atmosphere where people feel appreciated and valued, because in this context people are open to learning new ideas and encouraged to be creative. We all win when innovation is happening!

I was thinking about some of these tools when I logged into Facebook recently. Social media has become a major way people communicate with one another. Not only do we catch up on the simple life events, we also share big ideas about politics, philosophy, and hobbies. (Like RABBITS!) Statistics released in February 2018 state:

- There are over 2.13 BILLION users of Facebook worldwide,
- Five new profiles are created every second,
- Most people spent an average of 20 minutes on Facebook every time they log on
- 50% of 18-24 year olds go to Facebook when they wake up \*

It's a no brainer to state that social media use is a huge influence on our thoughts and attitudes about people and events. Yet sometimes our social media communication is less than ideal. Maybe we pick a fight, slander others, or let our temper rise to the point that our hotly worded comment just **MUST** be posted... to our own detriment later!

How do we make sure that our contribution to the larger social dialogue is positive? The kind of positive influence that won't make us smack our hands to our heads in embarrassment when we see the "One Year Ago Today" posts?

Here's an idea: within my professional life we say that "Good communication **KNITTS** us together." **KNITT** stands for **K**ind, **N**ecessary, (with) **I**ntegrity, **T**rue, **T**imely.

Let's unpack these ideas.

**KIND.** I love this quote by Ian MacLauren: *“Everyone you meet is fighting a battle you know nothing about. Be kind. Always.”* In a nutshell, if your words are barbed and your mood is nasty, it may not be the best time to hit the comment button! Unkind words are like little land mines, waiting to blow up unsuspecting folks. We don’t need more crippled people limping around the social landscapes. Do your part to believe the best and doubt the worst... and keep your fingers still when in doubt.

**NECESSARY.** One of the terms that has gotten coverage lately is “echo chamber.” This is generally the idea that you read the same thing so many times you begin to believe it’s true, whether it really is or not. Before you post anything on social media ask yourself, “Is this Necessary?” Are you contributing to the conversation with your post, or are you simply echoing what others have said before you? Deitrich Bonhoeffer is a notable dissenter of the Hitler regime of Nazi Germany. He credited his ability to influence national debate to his father, a respected medical administrator, who refused to let Deitrich speak at the dinner table unless his contribution was relevant and expanded the conversation. It trained his mind! When Deitrich Bonhoeffer did begin to speak, people listened and it changed their lives. Consider whether your words are necessary and if they can contribute in a useful way.

**INTEGRITY.** How does your conversation uphold integrity? Integrity is the qualification of being honest. But even more interesting Integrity is related to the word *integer* (remember math class?), which is a WHOLE. Is your communication whole-hearted? Are there pieces missing or facts that would fill in the blank to your communication? When you present yourself honestly, and wholly, whether the communication flatters your idea or not, you act with integrity and you gain the trust of those around you. In the rabbit world, this might mean telling someone the bad parts of that rabbit you’d really like to sell, or refusing to falsify a pedigree. Omitting the truth could provide short-term benefits, but telling the whole story will build your integrity and create long-term success.

**TRUE.** If you don’t know the Truth about a situation and are going off of hearsay, you’re a gossip. Stop talking or sending that DM. Put the phone down, walk away from the computer. Repeat only what you know to be True and go back to point number one for the rest: Grace believes the best and doubts the worst. Practice being graceful... and truthful in your online communication!

**TIMELY.** In a digital world where a moment is like an eternity, timely communication on social media is a challenge! Set some standards for timely communication, like “I will respond to messages within 24 hours” or “If that post is more than a week old, I won’t resurrect it with a new comment.” Be careful about jumping on the bandwagon and stirring the pot – to follow the metaphor, usually the stirred pot doesn’t produce a meal anyone wants to eat!

By following a few steps to think through well-KNITT communication, I hope that you'll find yourself a part of many excellent conversations in the future! Whether they are in person or online, may all your conversations be useful and enjoyable!

## SHIPPING RABBITS VIA AIRLINES FOR SHOWS OR TRANSPORT ALTERNATIVES

Several breeders use airlines as an option to get rabbits and themselves to shows across the country, and it is becoming a viable option since transport is not always available or reliable.

If you are not traveling on the same flight, most breeders I've spoken with are recommending United PetSafe. I used United PetSafe for my buck from Ohio.

Here are the steps needed when making your booking. Rabbits do not require a health certificate unless you are crossing out of the US, but you will want to verify this when making your booking. If you want to claim a value on the rabbits, then you would need a health certificate and a pre-travel health exam. This is taken from the United website:

“Upon making a booking for your pet, PetSafe will send you a PetSafe Customer Pre-travel information packet and a Customer Acknowledgement form. The packet is designed to inform customers on pre-travel planning, requirements and risks for pet travel. After you have reviewed the information in the packet, please complete and sign the Customer Acknowledgement Form. You must bring the form with you when you drop off your pet, or ensure that you have provided the person who may be dropping your pet off for you with the completed, signed form.

**A completed and signed Customer Acknowledgement Form must be presented at the time your pet is dropped off for travel with PetSafe.** The form summarizes the known risks of air travel for pets and the steps needed to prepare your pet for a safe journey. Copies of this form are available at every PetSafe drop-off location for customers who do not have access to a printer.

Rates will vary depending on caging sizes and weights. I had one rabbit shipped from Ohio to Las Vegas in a double transport cage, and it was \$140. If you are shipping more and using the dog crate with multiple cages inside, your prices will be higher. You will

need two dishes attached on the inside for food and water. You can attach extra food on top. Puppy pads work best for the liner in the bottom of the transport cage.

I found this to be an awesome and easy way to get my buck home because it was fast and easy. He was door to door (including my three hour drive home from Vegas) in 12 hours. Ground transport would have taken days, and I haven't had the best of luck going this route. I wanted to share this option for others to consider when they are needing to bring in new blood or even attend shows on the other side of the country. I have attached photos of both the dog kennel option (not my photos and were found on the Internet) and just the transport cage options. The ARBA also has a quick guide on shipping via airlines as well that you can find on the ARBA website at [https://www.arba.net/PDFs/airline\\_ref.pdf](https://www.arba.net/PDFs/airline_ref.pdf). I hope this helps everyone consider another option for traveling with their rabbits. It is a little more costly, but sometimes less time and less stress is money saved. Thanks,

Hello everyone,

I took over the sanctions and sweepstakes at the end of 2017 to help the club get this area back on track in this area. Unfortunately, the records that were passed to me are sparse so I need some help from the club. Over the past months I have been able to piece together quite a bit of information and below you will find a list of the shows that have been sanctioned during the current sweepstakes year, including those that that I do not have show reports for. You will also find the current sweepstakes points standings excluding shows for which the report is missing. If you know of a show where Blanc de Hotot was sanctioned and not listed please let me know. I will be trying to get in contact with the Show Secretaries regarding the missing show reports over the coming weeks.

According to the HRBI CBLs, the sanction year runs from July 1 – June 30. Points are awarded as follows according to the CBLs:

- Class Points
  - 6 points times number in the class for 1<sup>st</sup> place
  - 4 points times number in the class for 2<sup>nd</sup> place
  - 3 points times number in the class for 3<sup>rd</sup> place
  - 2. points times number in the class for 4<sup>th</sup> place
  - 1 points times number in the class for 5<sup>th</sup> place
  - NOTE: pre-junior classes do not count
  
- Specials Points
  - BOB 1 point times number in breed (pre-juniors excluded)
  - BOS 0.5 point times number in breed (pre-juniors excluded)
  - BIS or RIS 0.5 point times number of rabbits in the show
